## EXTRACT OF CONSTITUTION – ACADEMIC BOARD

### 3. Membership

- (1) The Committee comprises:
  - (a) **office-bearers** comprising:
    - (i) the Chair of the Academic Board;
    - (ii) the Deputy Chair of Academic Board;
    - (iii) the Associate Chair of Academic Board.
  - (b) **ex-officio members** comprising:
    - (i) the Vice-Chancellor;
    - (ii) the Senior Deputy Vice-Chancellor;
    - (iii) the Deputy Vice-Chancellor (Education);
    - (iv) the Deputy Vice-Chancellor Research);
    - (v) the Deputy Vice-Chancellor (International);
    - (vi) Heads of Schools;

  - (d) **nominated students** comprising:
