#### Overview

UWA Business School exchange participants are competitively selected against academic and other criteria.

The language of instruction at all our partner business schools is English.

You will receive full credit at the UWA Business School for studies taken at the overseas institution; units are to be approved by the MBA Studies Coordinator.

## Am I eligible for international studies?

- Are currently enrolled at the UWA Business School
- Have completed the required number of MBA units prior to studying abroad
- Enrolled in the MBA International / MBA Advanced
- Preferably a distinction average
- Are assessed as a suitable ambassador for the UWA Business School.
- \* (Subject to approval. Can be selected from ALMOST 100 UWA agreements). This option is usually fee payable.



## How long can I go for?

- Exchanges are from 3–6 months depending on the host institution
- Intensive Summer / Winter Schools (2–6 weeks)
- Transfers to offshore programs (Singapore, Manila, Jakarta) are for a program quarter
- Industry Study Program (times will vary)

#### The Fees

- Exchange partners waive tuition fees. You are responsible for meeting accommodation, living and travel expenses. You will pay your normal tuition fee to UWA
- Intensive Summer / Winter Schools are fees payable. This amount will vary and may include accommodation, some meals, and materials
- UWA Business School offshore program studies are payable at the local rate
- Industry Study Program incurs individual program fees

#### The Funds

To encourage students to acquire an international dimension to their MBA, the University provides some awards and scholarships. These are only available to partner exchanges and internships. Transfers, Intensive programs and Industry program participants may not be eligible.

#### **Application deadlines (approximate):**

1st April for studies June - November 1st August for studies January – June

#### **Full-Time Students:**

Must have completed two trimesters of full-time study

#### **Part-Time Students:**

Must have completed 8 units
