3. Membership
(1) The Committee comprises:

(f) the Pro Vice-Chancellor (Diversity, Equity and Inclusion) or nominee;
(g) the Director of Student Life or nominee;
(h) the Chief Marketing Officer or nominee;
(i) the Director UWA College or nominee;
(j) the Academic Secretary;
(k) the Associate Director (Admissions) or nominee;
(I) the Manager, Curriculum Management or nominee;
(m) five Heads of Schools or nominee elected by the College of Schools;
(n) three UWA academic staff members elected by and from the Academic Board;
(o) the Guild President or nominee;
