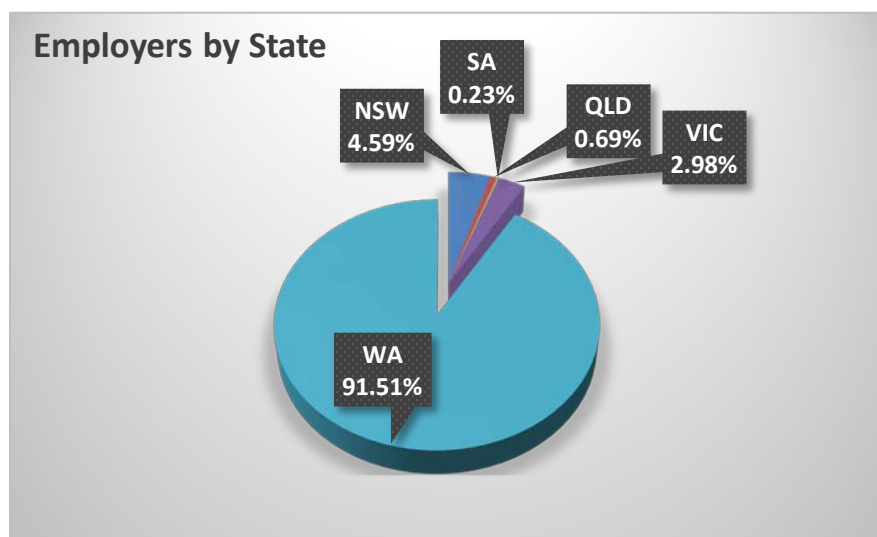
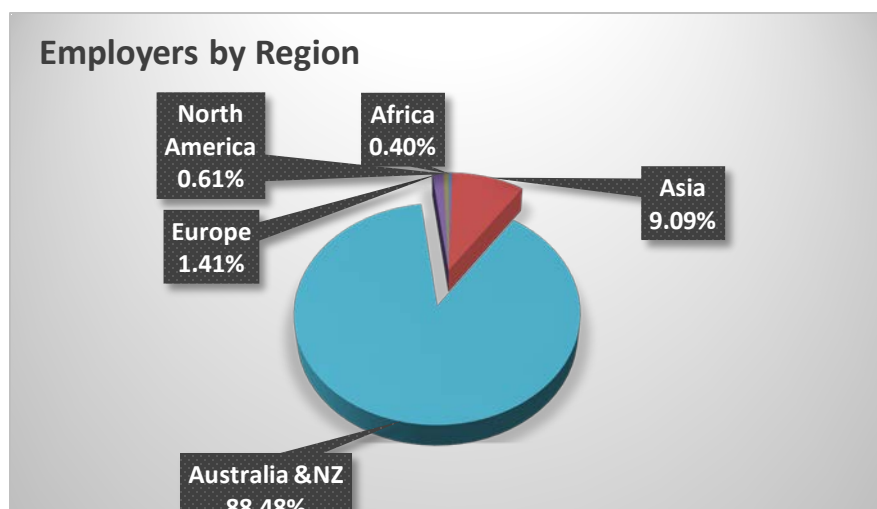
Total 801 students from the UWA Business School completed the Australian Graduate Destination Survey (AGDS) in 2018.

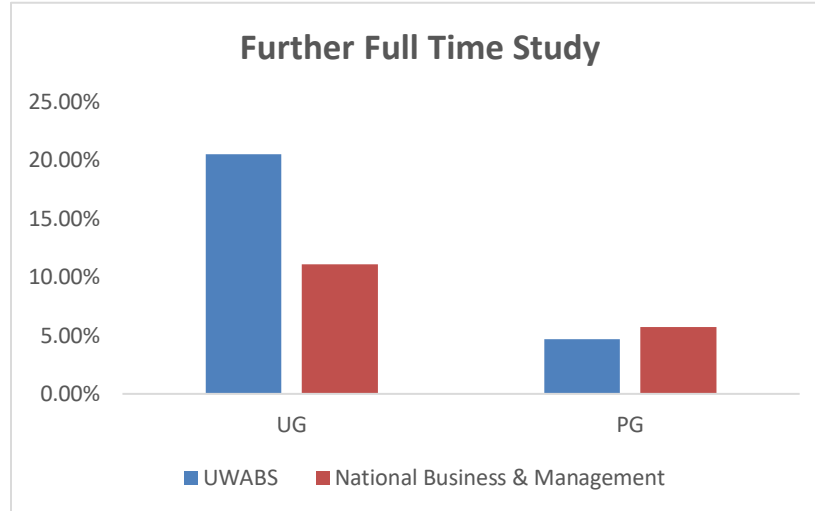
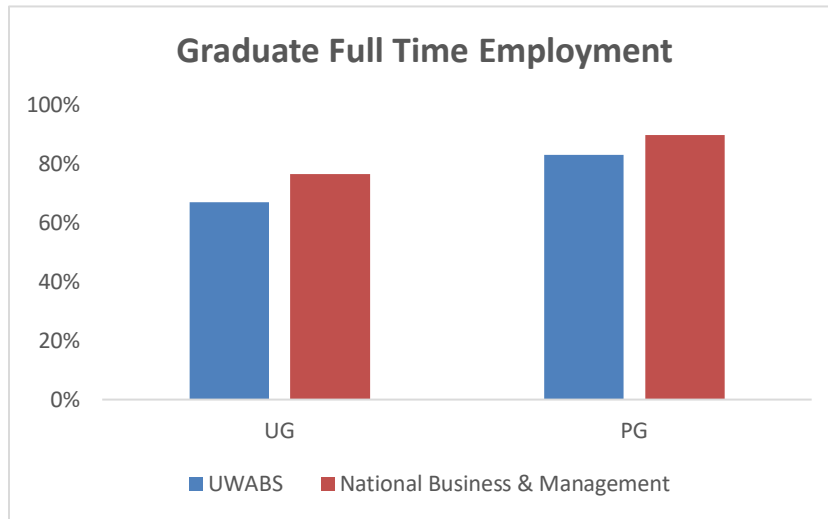
### Geographic distribution

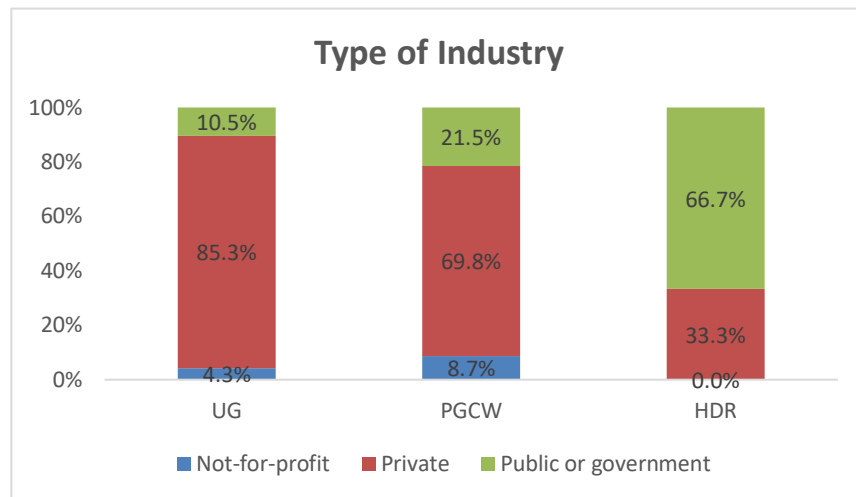


## Employment rates and type of work

Within four months after course completion, 67% of our undergraduate graduates were in full-time employment while 20.5% of them chose to pursue further full-time study; 83.2% of our postgraduate coursework graduates were in full time employment and 4.7% would conduct further study. (QILT graduate outcomes with surveys over 2016-2018).

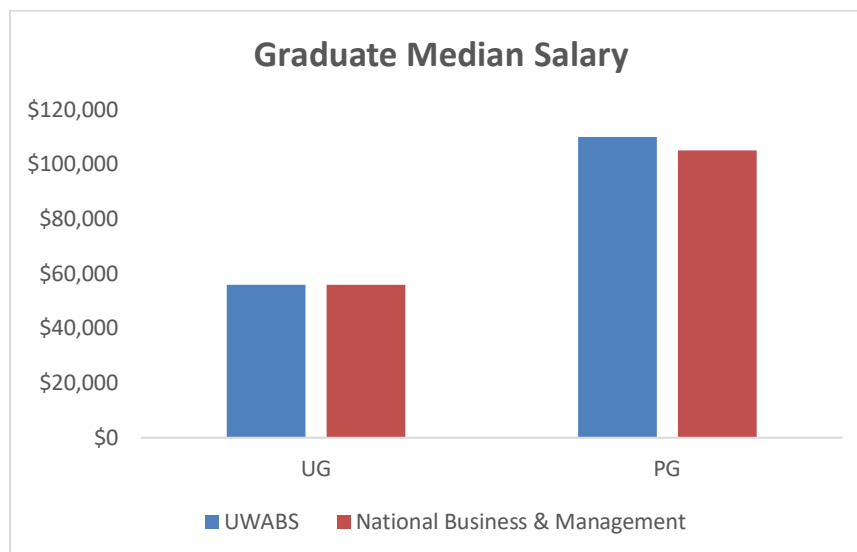


The majority of our undergraduate and postgraduate coursework graduates were working in the private sector, while a high proportion of HDR graduates (66.7%) were working in the public or government sector (AGDS).
