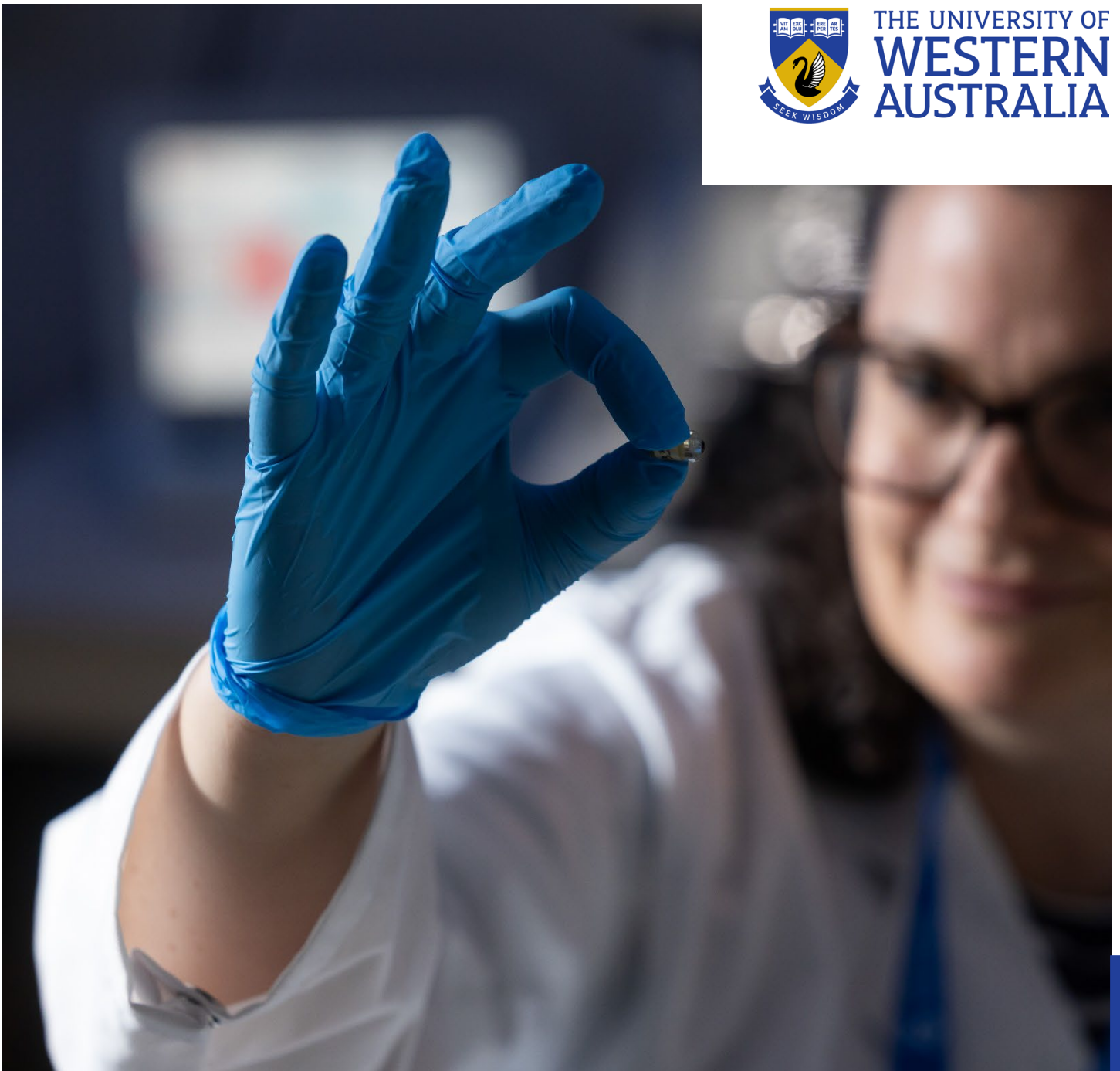

ACCESS OPTIONS

1. Users can pay for equipment access by the hour.
2. Users can pre-pay in advance for a capped number of hours, if available.
 - Capped blocks come in 50, 100, 200 and 400 hrs.
 - Pre-paid options are not transferrable and can only be used by a single user.
 - Pre-paid options expire 12 months from the date of purchase.
 - Once the balance gets to 0 hours, or /and the expiry date is reached, a new payment form must be submitted to re-activate the account.

INTERNAL UWA RATES

Eligibility: Subsidised internal rates apply to UWA staff and students, when the research funding is administered by UWA.

ADVICE FOR GRANT APPLICANTS

Researchers applying for grant funding are advised to calculate their microscopy and analysis budget based on the relevant hourly charge (do not incorporate subscriptions into the budget).
