Jenny Gregory AM, BA Hons, PhD (UWA), FRHS, Emeritus Professor of History, was elected Warden of Convocation in 2022 and is seeking your support for another term.

As 2026 Warden, she will continue to work collaboratively with Councillors to promote Convocation and to represent members' interests on matters affecting the University. She remains deeply committed to UWA.

Under her watch, following Senate approval and gazettal of the new UWA Statute, key governance changes to Convocation are being implemented. In alignment with Council's Strategic Plan 2023–26, changes include reducing Council size and increasing its demographic diversity. To improve recognition of Convocation's meaning and its representative role, Convocation Council has been renamed Alumni Council and Convocation now referred to as the UWA Alumni Association. Her leadership experience at UWA, as past President of the National Trust and the History Council of WA, and the support of Councillors, is ensuring a smooth transition during this period of change.

During her term, readership of the triannual Convocation Connecting e-bulletin has doubled, and engagement has risen at events, such as an expanded Convocation Day and in person and live-streamed General Meetings, with topical panel discussions on subjects like Higher Education and AI.

Council's relationship with Development and Alumni Relations has continued to strengthen through our Joint Committee and their valued support of Council activities. Joint activities include the establishment of a biennial Chancellor's reception honouring distinguished graduates.
