

International Student Release Form

International student visa holders must apply for a release from The University of Western Australia (UWA) if they are seeking to transfer to another CRICOS registered education provider in Australia. This is in accordance with Standard 7 of the National Code of Practice for Providers of Education and Training to Overseas Students <u>2018</u>.

Students must apply for a release to transfer if:

- they are currently studying in a pathway provider course, and do not wish to continue on to their principal degree course at UWA;
- they have completed their studies at a pathway provider, but do not wish to continue on to their principal degree course at UWA; or
- if they are currently enrolled in their principal degree course and have not completed at least six months of study.

You will not require a release if you have completed six months of your principal course.

Before applying, check the circumstances listed in the <u>UWA's website Release Requests</u> to find out when a release will or will not be granted. Then send the completed form, together with all other necessary documentation to UWA Admissions (admissions@uwa.edu.au).

Your application will be assessed within 10 working days. If your application meets the requirements, we will provide you with a release. If your application is not successful, we will inform you and outline the reason for this decision in writing.

- If you are a government-sponsored student, a written confirmation from your sponsor approving your transfer.

If you are under 18 years of age

- The above documentation.
- Written confirmation or approval from your parent or legal guardian supporting your transfer.
- If you are not living with a parent or suitable relative in Australia, we must receive written confirmation from
 the education provider you are seeking a transfer to that they will accept responsibility for your
 accommodation, support and general welfare arrangements.
