Master of Legal Practice

Specifically designed for overseas lawyers who wish to practise law in Western Australia. We understand each student will have different requirements, which is why we will create a unique study plan just for you.

The Master of Legal Practice is the only course of its kind offered in WA. It is structured for those who have fulfilled the requirements of a law degree and have been advised by the Legal Practice Board of Western Australia to undertake extra units of study in order to practise in this State.

You will graduate with the intellectual and practical skills needed to justify and interpret theoretical propositions, legal methodologies, conclusions and professional decisions. Graduates will be able to identify, research, evaluate and synthesise relevant factual, legal and policy issues, and communicate in ways that are effective, appropriate and persuasive for legal and non-legal audiences.

A unique study plan is provided, tailored to deliver exactly what you need from the course. You'll learn from world-class professors and study with the next generation of leaders in legal practice, government, business and the not-for-profit sector.

UWA's Law School is the fifth-oldest in Australia, and one of the top 100 law schools in the world, according to the QS World University Rankings by Subject 2018 (which also gives the School a five-star rating).



Recognition of prior learning

The length of this course varies, depending on any prior learning that UWA recognises.

This is a 96-point course. However up to 50 per cent of the required points (48) can be claimed from prior learning, meaning the course can be completed in one year.

A student who withdraws from the Master of Legal Practice course before completing it, but after completing 24 points or up to 42 points, may apply to the School to be awarded the Graduate Diploma in Legal Practice.

Career opportunities

The Master of Legal Practice provides graduates with the accreditation required to practise as a lawyer* in Western Australia.

You may end up working in government, at a law firm, as in-house council, or in the not-for-profit or community legal sectors.

Course structure

Each master's degree is tailored specifically to you, taking into account the requirements of the Legal Practice Board and your personal interests.
